KNOW ALL MEN BY THESE PRESENTS, That we, E. C. Goddard and Minnie M. Goddard, his wife, being of lawful age, in consideration of Ten Dollars, to them paid by A Dillinger do hereby Remise, Release and Forever QUITCLAIM unto the said A. Dillinger and unto his heirs and assigns, all their rights, title and interest in and to all that parcel of real estate situate in the County of Skamania State of Washington, to-wit:

Commencing at the 1/4 corner to Sections 16 and 21--T. 3 N.R.10 E. W.M. thence North 89°52' East 1866.3 feet to point of intersection with a line marking the Western bounrary of the right of way of the Great North Bank Highway, said point of intersections being 30.0 feet dist. at right angles with center line of Highway or 36.3 feet dist along line bearing N 89°52' East, thence along line limiting the Western boundary of the right of way of the Great North Bank Highway, N. 34°15' E. 36.3 feet to a point on Western line limiting said right of way of the Highway. thence S.89°52' W. 1886.8 feet, thence South 30.0ft. to 1/4 corner Sections 16 and 21, on the point of beginning, the said strip of land containing 1.291 acres, situated in the County of Skamania and State of Washington; said E. C. Goddard and Minnie M. Goddard reserve the right to use the land conveyed herein as a public highway
