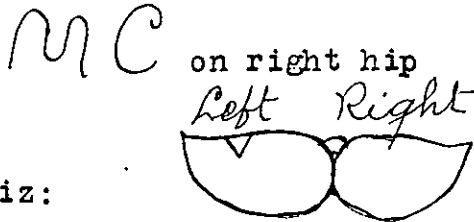
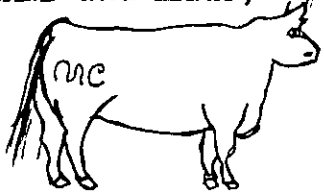

THIS INDENTURE WITNESSETH, That Bartholomew Bennett, a bachelor, of Portland, County of Multnomah, State of Oregon, party of the first part, for and in consideration of the sum of Seven Hundred and Fifty (\$750.00) Dollars in lawful money of the United States of America, to him in hand paid by Ben Del Grosso and Annie Del Grosso, husband and wife, of Cape Horn, County of Skamania, State of Washington. parties of the second part, has GRANTED, BARGAINED and SOLD, and by these presents does Grant, Bargain, Sell and Convey unto the said parties of the second part, and to their heirs and assigns, the following described real property, situate, lying and being in the County of Skamania, and State of Washington, to-wit:

Commencing at the center of Section Three (3), in Township One (1) North, of Range Five (5) East, of Willamette Meridian, at a stone set below the surface in the center of the County Road; thence along the East line of the Southwest quarter (SW $\frac{1}{4}$) of said Section Three (3) 8.49 chains to the Northeast corner of the school lot; thence South 80° 44' West along the North line of said school lot 6.78 chains; thence North 1° 46' East 9.30 chains to the center of the County road; thence along the center of the County road 87° 46' East .45 chains to the place of beginning, containing Six (6) acres, more or less.

TO HAVE AND TO HOLD the said premises, with all their appurtenances, unto the said parties of the second part, and to their heirs and assigns forever; and the said Bartholomew Bennett, party of the first part, for himself and for his heirs, executors and administrators, does hereby covenant to and with the said parties of the second part, their heirs, and assigns, that he is the owner in feesimple of said premises, and that they are free from all incumbrances and that he will
