SIMEON IMAN to A. C. SLY

THIS INDENTURE Made this 4th day of April 1919 between Simeon Iman, an unmarried man, party of the first part, and A. C. Sly, party of the second part,

WITNESSETH, that for and in consideration of the sum of \$75.00 to him in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, the said party of the first part does hereby GRANT, BARGAIN, SELL AND CONVEY unto the said party of the second part and to his heirs and assigns the following real property in Skamania County, State of Washington, to-wit;

Beginning at a post on the Northeast corner of the Daniel Baughman Donation Land Claim in Section One Township Two North of Range 7 East of W.M.; thence South along the east boundary of said Donation Land Claim 6 chains and 63 links to the meander line on the North bank of the Columbia River, being the South-erly line of said Boughman Donation Land Claim; thence North 77½deg. West 2 chains and 38 links along said boundary line; thence North 6 chains and 14 links to the North boundary line of said claim; thence East 2 chains and 33 links along said boundary line to the place of beginning containing One and One Half acres more or less, of land, all being in said Donation Land Claim.

The above described land being known as and assessed upon the tax roll of Skamania County, Washington for the year 1918 as Tax Lot No 42, and being the same property heretofore set aside to the said party of the first part in that certain degree of partition entered and filed in the case of Fredrick A. Kribs, plaintiff vs Myrtle Valet et al, defendants, on the 16th day of November 1911, and recorded in the office of the County Auditor of Skamania County on the 20th day of January 1912 at Page 451 Book N of Deeds.

TO HAVE AND TO HOLD unto the said party of the second part, and to his heirs and assigns forever. And the said party of the first part does hereby covenant and agree, for himself and for his heirs, administrators and executors, to and with the said party of the second part, his heirs and assigns, that he is the owner in fee simple of the said premises, that he has good right to sell and convey
