C. PALMER PARTY OF THE SECOND PART, THE FOLLOWING DESCRIBED PREMISES, TO-WIT:

ALL THE NORTH HALF OF THE SOUTHEAST QUARTER AND THE SOUTH HALF OF THE NORTHEAST QUARTER OF SECTION NINETEEN AND THE SOUTH HALF OF THE NORTHWEST QUARTER AND THE NORTH HALF OF THE SOUTHWEST QUARTER OF SECTION TWENTY, ALL IN TOWNSHIP TWO, NORTH OF RANGE FIVE EAST OF THE WILLAMETTE MERIDIAN, CONTAINING THREE HUNDRED AND TWENTY ACRES, MORE OR LESS IN SKAMANIA COUNTY, WASHINGTON.
