THE NORTHWEST QUARTER (NW $\frac{1}{4}$) AND THE SOUTHEAST QUARTER (SE $\frac{1}{4}$) OF SECTION TWENTY-ONE (21), TOWNSHIP TWO (2) NORTH, RANGE FIVE (5) E. W.M.; ALSO ALL OF THE TIMBER UPON THE NORTHEAST QUARTER (NE $\frac{1}{4}$) OF SAID SECTION 21, TOWNSHIP 2 NORTH, RANGE 5 E. W.M., TOGETHER WITH THE SAWMILL AND SAWMILL AND LOGGING MACHINERY AND EQUIPMENT SITUATED UPON THE SAID NORTHWEST QUARTER (NW $\frac{1}{4}$) OF SAID SECTION 21, TOWNSHIP 2 NORTH, RANGE 5 EAST OF THE W.M., TOGETHER WITH ALL AND SINGULAR THE TENEMENTS, HEREDITAMENTS AND APPURTENANCES THERETO BELONGING OR IN ANY WISE APPERTAINING.
