WITNESSETH:

WHEREAS, J. P. O'BRIEN AND R. BLAISDELL, ARE OWNERS, IN TRUST FOR THE BENEFIT OF OREGON-WASHINGTON RAILROAD & NAVIGATION COMPANY, AN OREGON CORPORATION, SUCCESSOR IN INTEREST TO OREGON RAILROAD AND NAVIGATION COMPANY, OF THE FOLLOWING DESCRIBED LANDS:

PARCEL NO. 1.
