THE SOUTHWEST QUARTER OF SECTION ELEVEN, TOWNSHIP TWO (2) NORTH OF RANGE FIVE (5) EAST OF THE WILLAMETTE MERIDIAN IN <sup>SK</sup>SKAMANIA COUNTY STATE OF OREGON.
