THIS INDENTURE MADE THIS 3RD DAY OF DECEMBER 1920 BETWEEN GEORGIA M. NICHOLS, A WIDOW, PARTY OF THE FIRST PART, AND CARL H. STEWART AND HATTIE B. STEWART HIS WIFE PARTIES OF THE SECOND PART, WITNESSETH:

THAT THE SAID PARTY OF THE FIRST PART FOR AND IN CONSIDERATION OF THE SUM OF TWELVE THOUSAND AND NO/100 DOLLARS TO HER IN HAND PAID BY THE SAID PARTIES OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY CONFESSED AND ACKNOWLEDGED, DOES BY THESE PRESENTS GRANT, BARGAIN, SELL AND CONVEY UNTO THE SAID PARTIES OF THE SECOND PART AND TO THEIR HEIRS AND ASSIGNS, THE FOLLOWING REAL PROPERTY IN SKAMANIA COUNTY, WASHINGTON, TO-WIT:

COMMENCING AT THE SOUTHWEST CORNER OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION TWENTY-ONE(21) TOWNSHIP THREE (3) NORTH OF RANGE EIGHT (8) EAST OF THE WILLAMETTE MERIDIAN, RUNNING THENCE NORTH SIX HUNDRED NINETY (690) FEET, THENCE EAST SIX HUNDRED NINETY (690) FEET, THENCE SOUTH SIX
