SECOND: THE SAID J. P. O'BRIEN, TRUSTEE, AND OREGON-WASHINGTON RAILROAD & NAVIGATION COMPANY, BENEFICIARY, HAVE RELEASED AND DO HEREBY RELEASE THE SAID R.
