KNOW ALL MEN BY THESE PRESENTS, THAT CHRIST FLETCH THE PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLARS LAWFUL MONEY OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY AURELIA KELLY AND ELI KELLY, WIFE AND HUSBAND THE PARTIES OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO BY THESE PRESENTS GRANT, BARGAIN, SELL, ASSIGN, TRANSFER AND SET OVER UNTO THE SAID PARTIES OF THE SECOND PART, A CERTAIN INDENTURE OF MORTGAGE BEARING DATE THE 31ST DAY OF MAY, A. D. 1927, MADE AND EXECUTED BY L. A.
