WHEREAS, UNDER DATE OF MAY 16, 1927, PEOPLES WEST COASTS HYDRO-ELECTRIC CORPORATION, AND PEOPLES TRUST AND SAVINGS BANK AND A. L. WARNER, TRUSTEE, DULY MADE, EXECUTED AND DELIVERED TO SECURITY SAVINGS AND TRUST COMPANY, AN OREGON CORPORATION, AS SUBSTITUTE TRUSTEE, A SECOND SUPPLEMENTAL INDENTURE, WHICH SECOND SUPPLEMENTAL INDENTURE WAS DULY RECORDED AND FILED IN ALL THE OFFICES MENTIONED ON PAGE 1 HEREOF; AND

WHEREAS, PEOPLES TRUST AND SAVINGS BANK AND A. L. WARNER HAVE DULY RESIGNED AS TRUSTEES UNDER THE INDENTURE OF MORTGAGE AND THE EQUITABLE TRUST COMPANY OF NEW YORK AND SAMUEL ARMSTRONG, HAVE, IN THE MANNER PROVIDED IN THE INDENTURE OF MORTGAGE, BEEN DULY DESIGNATED AND APPOINTED AS TRUSTEES UNDER THE INDENTURE OF MORTGAGE TO SUCCEED PEOPLES TRUST AND SAVINGS BANK AND A. L. WARNER, RESIGNED, AND HAVE DULY ACCEPTED THE APPOINTMENTS AS SUCCESSOR TRUSTEES UNDER THE INDENTURE OF MORTGAGE; AND

WHEREAS, THE EQUITABLE TRUST COMPANY OF NEW YORK IS A TRUST COMPANY ORGANIZED UNDER THE LAWS OF THE STATE OF NEW YORK AND HAS A CAPITAL AND SURPLUS AGGREGATING AT LEAST \$500,000, AND SAMUEL ARMSTRONG IS A CITIZEN OF THE UNITED STATES, AND BOTH ARE EMPOWERED AND ABLE TO RECEIVE CONVEYANCES OF PROPERTY TO BE HELD UPON SUCH TRUSTS AS THOSE IN THE INDENTURE OF MORTGAGE SET FORTH, AND ARE WILLING TO ACT AS TRUSTEES UNDER THE INDENTURE OF MORTGAGE;

WARNER, IN CONSIDERATION OF THE PREMISES AND OF OTHER GOOD AND VALUABLE CONSIDERATION, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, HAVE EXECUTED AND DELIVERED THIS INDENTURE AND HAVE GRANTED, BARGAINED, SOLD, ALIENED, REMISED, RELEASED, QUITCLAIMED,
