HUGGINS HAB BEEN REQUESTED AND HEREBY IS REQUESTED TO EXECUTE THIS DEED OF RELEASE IN THE NAME AND ON BEHALF OF THE FIDELITY TRUST COMPANY, AND ALL OTHER THINGS NECESSARY OR PROPER TO BE DONE TO AUTHORIZE HIM TO EXECUTE THIS DEED OF RELEASE HAVE BEEN DONE AND PERFORMED; AND

WHEREAS, BY APPROPRIATE CORPORATE ACTION, FIDELITY TRUST COMPANY AND PHILADELPHIA TRUST COMPANY, CORPORATIONS ORGANIZED AND FORMERLY EXISTING UNDER THE LAWS OF THE STATE OF PENNSYLVANIA, HAVE BEEN CONSOLIDATED INTO FIDELITY-PHILADELPHIA TRUST COMPANY, WHICH CORPORATION HAS SUCCEEDED TO ALL THE RIGHTS, PRIVILEGES AND FRANCHISES OF THE CONSOLIDATED CORPORATIONS.

NOW, THEREFORE, THE FIDELITY-PHILADELPHIA TRUST COMPANY, AS TRUSTEE UNDER THE SAID MORTGAGE DATED FEBRUARY 1,1912, AND THE SAID SUPPLEMENTAL MORTGAGES DATED MAYI, 1912, AND DECEMBER I, 1919, AND JUNE 10, 1926, AS WELL IN THE CONSIDERATION OF THE PREMISES AS OF THE SUM OF ONE DOLLAR (\$1.00) LAWFUL MONEY TO IT IN HAND PAID BY THE SAID PORTLAND ELECTRIC POWER COMPANY (FORMERLY PORTLAND RAILWAY, LIGHT AND POWER COMPANY) AT OR BEFORE THE ENSEALING AND DELIVERY OF THESE PRESENTS, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDHED, HAS REMISED, QUIT-CLAIMED, EXONERATED AND DISCHARGED, AND BY THESE PRESENTS DOES REMISE, QUIT-CLAIM, EXONERATE AND DISCHARGE UNTO THE SAID PORTLAND ELECTRIC POWER COMPANY (FORMERLY PORTLAND RAILWAY, LIGHT AND POWER COMPANY) ITS SUCCESSORS AND ASSIGNS, ALL THOSE CERTAIN PIECES OF REAL PROPERTY LOCATED IN THE COUNTY OF MULTNOMAH AND STATE OF OREGON, AND COUNTY OF SKAMANIA AND STATE OF WASHINGTON, DESCRIBED AS FOLLOWS:

ALL THE FOLLOWING DESCRIBED REAL PROPERTY, RIGHTS, EASEMENTS AND PRIVILEGES SITUATED IN THE COUNTY OF MULTNOMAH IN THE STATE OF OREGON, BEING PART OF THE WATER POWER PROPERTIES AND RIGHTS REFERRED TO IN SECTION 1, ARTICLE EIGHT OF THE FIRST AND REFUNDING MORTGAGE AND DEED OF TRUST FROM PORTLAND RAILWAY COMPANY TO THE NEW YORK TRUST COMPANY, TRUSTEE, AS OF DATE NOVEMBER 1, 1905, TO-WIT:
