KNOW ALL MEN BY THESE PRESENTS, THAT WE, GEROGE J. HAFLEY AND IRENE HOFFMAN (FORMERLY IRENE HAFLEY), OF CAPE HORN, WASHINGTON, AND MARGARET HAFLEY, OF PORTLAND, OREGON, BEING THE GRANDCHILDREN AND WITH MAGGIE HANLON, THE GRANTEE HEREIN, THE SOLE HEIRS AT LAW OF CORNELIUS O. HANLON, DECEASED, LATE OF THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, IN CONSIDERATION OF TEN DOLLARS (\$10.00) AND OTHER GOOD AND VALUABLE CONSIDERATIONS TO US PAID BY MAGGIE HANLON, OF CAPE HORN, COUNTY OF SKAMANIA, IN THE STATE OF WASHINGTON, DO HEREBY REMISE, RELEASE, CONVEY AND QUITCLAIM UNTO THE SAID MAGGIE HANLON, AND UNTO HER HEIRS AND ASSIGNS FOREVER, ALL OUR RIGHT, TITLE, CLAIM AND INTEREST IN AND TO ALL THE FOLLOWING DESCRIBED TRACTS, PIECES OR PARCELS OF REAL PROPERTY, SITUATE IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

THE SOUTHEAST QUARTER OF THE NORTHEAST QUARTER ($SE\frac{1}{4}$ OF $NE\frac{1}{4}$), THE NORTH HALF OF THE SOUTHEAST QUARTER ($N\frac{1}{2}$ OF $SE\frac{1}{4}$) AND THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER ($NE\frac{1}{4}$ OF $SW\frac{1}{4}$) OF SECTION THIRTY-THREE (33), AND THE WEST HALF OF THE NORTHWEST QUARTER ($W\frac{1}{2}$ OF $NW\frac{1}{4}$) AND THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER ($NW\frac{1}{4}$ OF $SW\frac{1}{4}$) OF SECTION THIRTY-FOUR (34), IN TOWNSHIP TWO (2) NORTH, OF RANGE FIVE (5) EAST, OF WILLAMETTE MERIDIAN, CONTAINING 280 ACRES.

ALSO, THE NORTH HALF OF THE NORTHEAST QUARTER ($N\frac{1}{2}$ OF $NE\frac{1}{4}$) AND THE NORTH HALF OF THE NORTHWEST QUARTER ($N\frac{1}{2}$ OF $NW\frac{1}{4}$) OF SECTION FIVE (5), IN TOWNSHIP ONE (1) NORTH, OF RANGE FIVE (5) EAST, OF WILLAMETTE MERIDIAN, CONTAINING 160 ACRES.
