P. S. C. WILLS TO FANNIA A. ARNOLD ET AL

THIS INDENTURE, MADE AND ENTERED INTO BY AND BETWEEN P. S. C. WILLS, A SINGLE MAN, PARTY OF THE FIRST PART AND FANNIE A. ARNOLD AND ALEX McKEIGHAN, PARTIES OF THE SECOND PART, WITNESSETH:

WHEREAS, THE PARTIES OF THE FIRST PART HERETOFORE, TO-WIT ON THE 30TH DAY OF APRIL, 1927, MADE, EXECUTED AND DELIVERED TO THE PARTIES OF THE SECOND PART A CERTAIN INDENTURE OF MORTGAGE SECURING THE SUM OF \$2900.00 AS EVIDENCED BY THIRTY CERTAIN PROMISSORY NOTES THEREIN DESCRIBED, WHICH SAID INDENTURE OF MORTGAGE WAS DULY FILED FOR RECORD IN THE OFFICE OF THE AUDITOR OF SKAMANIA COUNTY, WASHINGTON AND RECORDED AT PAGE 151 BOOK "S" OF MORTGAGES RECORDS OF SAID COUNTY;

WHEREAS, THE SAID MORTGAGE CONVEYS, AMONG OTHER PROPERTY, CERTAIN EASEMENTS, FRANCHISES AND PIPE LINE TO BE SECURED AND CONSTRUCTED WITH THE MONEYS SECURED BY SAID MORTGAGE WHICH SAID EASEMENTS, FRANCHISES AND PIPE LINE ARE DESCRIBED IN SAID MORTGAGE;

WHEREAS, IT IS PROVIDED IN SAID MORTGAGE THAT UPON COMPLETION OF SAID WORK THE PARTY OF THE FIRST PART SHALL EXECUTE TO THE PARTIES OF THE SECOND PART SUCH INSTRUMENT OR CONVEYANCE OF FURTHER ASSURANCE WITH REFERENCE THERETO AS MAY BE BY THE SAID PARTIES OF THE SECOND PART CONSIDERED NECESSARY AND PROPER IN THE PREMISES; AND

WHEREAS, THE WORK MENTIONED IN SAID MORTGAGE HAS BEEN COMPLETED AND PAID FOR OUT OF THE PROCEEDS OF THE SAID LOAN.

NOW, THEREFORE IN CONSIDERATION OF THE SUM OF \$1.00 TO HIM IN HAND PAID, AND IN ACCORDANCE WITH THE TERMS AND PROVISIONS OF SAID INDENTURE OF MORTGAGE, AS A FURTHER ASSURANCE TO THE SAID PARTIES OF THE SECOND PART, THE SAID PARTY OF THE FIRST PART DOES HEREBY GRANT, BARGAIN, SELL, CONVEY AND WARRANT UNTO THE SAID PARTIES OF THE SECOND PART THE FOLLOWING DESCRIBED PROPERTY, TO-WIT:

THE PIPE, PIPING, PIPE LINE, AND EASEMENTS FOR PIPE LINE EXTENDING FROM SPRING SITUATED IN THE NORTHEAST QUARTER OF SE $\frac{1}{4}$ OF SEC. 34, TWP. 3 N. R. 7 E. W. M. THENCE EASTERLY OVER SECTION THIRTY-FOUR AND THIRTY-FIVE TO BRIDGE ACROSS ROCK CREEK ON THE RYAN-ALLEN COUNTY ROAD THENCE FOLLOWING THE RYAN-ALLEN COUNTY ROAD TO INTERSECTION OF ROCK CREEK ROAD THENCE FOLLOWING SAID ROCK CREEK ROAD TO INTERSECTION WITH MCKINLEY STREET IN ROSELAWN ADDITION TO THE TOWN OF STEVENSON WHICH SAID PIPE, PIPE LINE, AND EASEMENTS HAVE BEEN PURCHASED AND CONSTRUCTED FROM THE PROCEEDS OF THIS LOAN AND IMMEDIATELY UPON CONSTRUCTION BECAME SUBJECT TO THE LIEN OF SAID MORTGAGE.
