AND STATE OF WASHINGTON, MY TRUE AND LAWFUL ATTORNEY FOR ME AND IN MY NAME, PLACE AND STEAD, TO SELL AND DISPOSE OF ^A/CERTAIN LOAN IN THE PRINCIPAL SUM OF \$2500.00 HERETOFORE MADE BY ME TO THE APPLE GROWERS UNION OF THE WHITESALMON VALLEY, PAYMENT WHEREOF IS SECURED BY A MORTGAGE OR TRUST DEED FROM SAID UNION CONVEYING CERTAIN LAND AND BUILDINGS AT UNDERWOOD IN SAID STATE OF WASHINGTON, AND IN CONNECTION WITH SUCH SALE AND DISPOSITION TO ASSIGN AND DELIVER TO ANY PURCHASER THEREOF SAID MORTGAGE OR TRUST DEED TOGETHER WITH ANY AND ALL NOTES OR OTHER INSTRUMENTS EVIDENCING SAID INDEBTEDNESS GIVING AND GRANTING UNTO MY SAID ATTORNEY FULL POWER AND AUTHORITY TO DO AND PERFORM ALL AND EVERY ACT AND THING WHATSOEVER, REQUISITE AND NECESSARY TO BE DONE IN AND ABOUT THE PREMISES, AS FULLY, TO ALL INTENTS AND PURPOSES, AS I MIGHT OR COULD DO IF PERSONALLY PRESENT AT THE DOING THEREOF, WITH FULL POWER OF SUBSTITUTION AND REVOCATION, HEREBY RATIFYING AND CONFIRMING ALL THAT MY SAID ATTORNEY OR HIS SUBSTITUTE SHALL LAWFULLY DO OR CAUSE TO BE DONE BY VIRTUE HEREOF.
