### ASSIGNMENT OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS: THAT I, ANGUS P. HANLEY, THE PARTY OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF TEN DOLLARS (\$10.00) IN GOLD COIN OF THE UNITED STATES OF AMERICA, TO HIM IN HAND PAID BY HENRIETTA HANLEY, THE PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DOES BY THESE PRESENTS GRANT, BARGAIN, SELL, ASSIGN, TRANSFER AND SET OVER, UNTO THE SAID PARTY OF THE SECOND PART, A CERTAIN INDENTURE OF MORTGAGE, BEARING DATE THE 16TH DAY OF JUNE, ONE THOUSAND NINE HUNDRED AND TWENTY-FIVE, MADE AND EXECUTED BY I. P. IRONS AND D. M. IRONS, HUSBAND AND WIFE, MORTGAGORS TO ANGUS P. HANLEY, MORTGAGEE AND RECORDED ON THE 18TH DAY OF JUNE, 1925, IN LIBER R OF MORTGAGES AT PAGE 264 IN THE OFFICE OF THE COUNTY RECORDER OF THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TOGETHER WITH THE PROMISSORY NOTE THEREIN DESCRIBED, AND THE MONEY DUE AND TO GROW DUE THEREON, WITH THE INTEREST.

TO HAVE AND TO HOLD THE SAME UNTO THE SAID PARTY OF THE SECOND PART, HER HEIRS, EXECUTORS, ADMINISTRATORS AND ASSIGNS FOR HER USE AND BENEFIT; SUBJECT ONLY TO THE PROVISIO IN THE SAID INDENTURE OF MORTGAGE MENTIONED. AND THE SAID PARTY OF THE FIRST PART DOES HEREBY MAKE, CONSTITUTE AND APPOINT THE SAID PARTY OF THE SECOND PART HIS TRUE AND LAWFUL ATTORNEY IRREVOCABLE IN HIS NAME OR OTHERWISE, BUT AT THE PROPER COSTS AND CHARGES OF THE SAID PARTY OF THE SECOND PART, TO HAVE, USE AND TAKE ALL LAWFUL WAYS AND MEANS FOR THE RECOVERY OF THE SAID MONEY AND INTEREST; AND IN CASE OF PAYMENT TO DISCHARGE THE SAME AS FULLY AS THE SAID PARTY OF THE FIRST PART MIGHT OR COULD DO IF THESE PRESENTS WERE NOT MADE.
