AND THE SAID FIRST PARTIES SHALL, IN CASE OF SUCH DEFAULT, HAVE THE RIGHT IMMEDIATELY, OR AT ANY TIME THEREAFTER, TO ENTER UPON THE LAND AFORESAID, WITH-OUT ANY PROCESS OF LAW AND TAKE IMMEDIATE POSSESSION THEREOF, TOGETHER WITH ALL IMPROVEMENTS AND APPURTENANCES THEREON OR THERETO BELONGING.
