PROVIDED ALWAYS, NEVERTHELESS, THAT NOTHING HEREIN CONTAINED SHALL IN ANYWISE EFFECT, ALTER OR DIMINISH THE LIEN OR ENCUMBRANCE OF THE AFORESAID MORTGAGES ON THE REMAINING PARTS OF THE PROPERTIES, PREMISES AND FRANCHISES COVERED BY THEM RESPECTIVELY, OR THE REMEDIES GIVEN BY THEM RESPECTIVELY, AGAINST THE SAID PORTLAND RAILWAY, LIGHT AND POWER COMPANY (Now Portland Electric Power Company) ITS SUCCESSORS AND ASSIGNS, AS SECURITY FOR THE BONDS AND PERFORMANCE OF THE ACTS SECURED BY THEM RESPECTIVELY.
