BOOK S OF DEEDS, RECORDS OF SKAMANIA COUNTY, WASHINGTON. (THIS CONVEYS AN UNDIVIDED 11/12 INTEREST NOW OWNED BY GRANTOR, AND ALL HIS RIGHT TITLE AND INTEREST
