First M. E. Church to Board of Home Missions

THIS INDENTURE, Made this 23d day of November 1927 between The First Methodist Episcopal Church of Stevenson, Washington, a corporation, by its Trustees, the party of the first part, and The Board of Home Missions and Church Extension of the Methodist Episcopal Church, the party of the second part,

WITNESSETH, That the said party of the first part, for and in consideration of the sum of Four Thousand (\$4000.00) Dollars, lawful money of the United States, to it in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain, sell, convey and confirm unto the said party of the second part, and to its (their) successors in office, the following described tract or parcel of land, lying and being in the County of Skamania, State of Washington, to-wit:

Lots one (1) and two (2) in Block six (6) of Johnson's Addition to the Town of Stevenson, Washington, according to the official plat thereof on file and of record in the office of the Auditor of Skamania County, Washington, excepting therefrom a strip of land fourteen (14) feet in width from the south end of the aforesaid lots heretofore granted as a right of way, Together with all and singular the tenements, hereditaments and appurtenances thereto belonging.

This Conveyance is intended as a MORTGAGE, to secure the payment of the sum of Four Thousand (\$4000.00) Dollars, lawful money of the United States, together with interest thereon in like lawful money at the rate of five (5) per, cent. per annum, payable semi-annually, from date until paid, according to the terms and conditions of five (5) certain promisory notes bearing date November 23d, 1927 made by the said Trustees of the said First Methodist Episcopal Church of Stevenson, Washington payable to the Board of Home Missions
