WITNESSETH, THAT THE SAID PARTIES OF THE FIRST PART, FOR AND IN CON-
SIDERATION OF THE SUM OF ONE DOLLARS, TO THEM IN HAND PAID BY THE SAID PARTY OF
THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO HEREBY GRANT,
BARGAIN, SELL AND CONVEY, UNTO THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND
ASSIGNS, FOREVER, ALL THAT TRACT OR PARCEL OF LAND, LYING AND BEING IN THE COUNTY
OF SKAMANIA AND STATE OF WASHINGTON, AND DESCRIBED AS FOLLOWS, TO-WIT:

WEST HALF OF NORTHWEST QUARTER ($W\frac{1}{2} NW\frac{1}{4}$), SOUTHEAST QUARTER OF THE NORTH-
WEST QUARTER ($SE\frac{1}{4} NW\frac{1}{4}$) AND THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER ($SW\frac{1}{4}$
 $NE\frac{1}{4}$) SECTION ONE (1) TOWNSHIP ONE (1) NORTH OF RANGE 5 EAST OF THE WILLAMETTE
MERIDIAN.

MANNER AND FORM AFORESAID; THAT THE SAME ARE FREE FROM ALL INCUMBRANCES EXCEPT
A MORTGAGE FOR \$600.00 AND INTEREST THEREON, AND UNPAID TAXES.

AND THE ABOVE BARGAINED AND GRANTED LANDS AND PREMISES, IN THE QUIET AND PEACEFUL
POSSESSION OF THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, AGAINST
ALL PERSONS LAWFULLY CLAIMING, OR TO CLAIM THE WHOLE OR ANY PART THEREOF, THE
SAID PARTIES OF THE FIRST PART WILL WARRANT AND DEFEND, EXCEPT AS TO INCUMBRANCES
ABOVE MENTIONED.
