KNOW ALL MEN BY THESE PRESENTS, THAT MAE LOUGEE OF THE CITY OF SAN FRANCISCO, STATE OF CALIFORNIA, BEING THE OWNER OF EIGHT-TENTHS (8/10), J. F. WILLIAMS AND RICHARD NAYLOR OF THE CITY OF PORTLAND, STATE OF OREGON, EACH BEING THE OWNER OF AN UNDIVIDED ONE-TENTH (1/10) OF THE MINING PROPERTY HEREINAFTER DESCRIBED, FOR AND IN CONSIDERATION OF THE SUM OF ONE & 00/100 DOLLARS (\$1.00) AND OTHER VALUABLE CONSIDERATIONS TO THEM MOVING, BY COLUMBIA RIVER GOLD AND COPPER COMPANY, A CORPORATION, DULY ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF THE LAWS OF THE STATE OF WASHINGTON, WITH ITS PRINCIPAL OFFICE IN THE CITY OF VANCOUVER, IN SAID STATE, THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, HAVE GRANTED, BARGAINED, SOLD AND CONVEYED AND BY THESE PRESENTS DO GRANT, BARGAIN, SELL AND CONVEY UNTO SAID COLUMBIA RIVER GOLD AND COPPER COMPANY, ITS SUCCESSORS AND ASSIGNS, ALL OF THEIR RIGHT, TITLE AND INTEREST IN AND TO THE FOLLOWING DESCRIBED MINING CLAIMS, LYING, BEING AND SITUATE IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, TO-WIT:

TO HAVE AND TO HOLD, ALL AND SINGULAR THE SAID PREMISES, TOGETHER WITH THE APPURTENANCES AND PRIVILEGES THEREUNTO INCIDENT, UNTO THE SAID GRANTEE, ITS SUCCESSORS AND ASSIGNS FOREVER.
