

WHEREAS, All the lands hereinafter described have been sold and conveyed by the Northern Pacific Railway Company(which has succeeded to the right, title and interest in said lands of the Northern Pacific Railroad Company) by several deeds in various parcels; and WHEREAS, The said mortgage has been satisfied and the moneys required for the payment of all the bonds secured thereby have not been deposited by means of operation of the sinking fund of said mortgage or otherwise, and WHEREAS, The said Trustee has received the net proceeds arising from the sale of the said lands hereinafter described, as provided in said mortgage; NOW THEREFORE, This Indenture ~~Wt~~ Witnesseth that the party of the first part, as Trustee, as aforesaid, in consideration of the premises and the payment to it of the net proceeds arising from the sale of said ~~tax~~ lands, the receipt ~~whereof~~ is hereby acknowledged, does hereby release all its right title and interest, as trustee to said land from the lien of said mortgage the following described pieces and parcels of land, situate in the county of Skamania and State of Washington and herein described according to the United States survey:

Those parts of lots two(2), three(3), four (4), southwest quarter of the Northwestquarter, southeast quarter of northwest quarter, northeast quarter of ~~shethwest~~ quarter and north half of southeast quarter of section seven (7), in Township ten(10) north range six(6) East of the Willamett Meridian, as shown on the official plat of survey of said township accepted May 22, 1912, which lies within the boundaries of lode claims Sam Henry No.1, Sam Henry No.2, Invincible No.1, Invincible No.2, Invincible No.3, Viola No.1, Viola No.4, Viola No.5, Sandow No.1, Sandow No.2, Last Chance No.1, Last Chance No.2, Big Edd No.1, and Big Edd No.2, as the same appears on the official supplemental plat of section seven(7) dated January 16, 1925 accepted February 3, 1925; Also that part of lot two(2) of Section twenty-nine(29) in Township ten (10) North range six(6) East of the Willamett Meridian lying within the boundaries of Mineral survey No.829, containing in all one hundred forty and ten hundredths(140.10) acres more or less.

And the said party of the first part ^{hereby} covenants and agrees with the said party of the second part that the said several grantees of said party of the second part shall ~~not~~ hold the respective pieces and parcels of land so conveyed to them by the said party of the second part free and clear and discharged from the lien and encumbrances of said mortgage, and the payment of the sum or sums of money therein expressed, and every part thereof.
