I, JAMES ALLEN, BEING FIRST DULY SWORN, ON OATH SAY:

I AM THE DULY QUALIFIED AND ACTING HIGHWAY COMMISSIONER OF THE STATE OF WASHINGTON. ATTACHED HERETO IS A MAP OR TRACING MADE ON LINEN WHICH IS A TRUE AND CORRECT COPY OF AN ORIGINAL MAP ON FILE IN MY OFFICE SHOWING THE LOCATION OF STATE ROAD NO. 8 OF THE STATE OF WASHINGTON AS THE SAME WAS SURVEYED AND LOCATED THROUGH SECTIONS FOURTEEN (14), FIFTEEN (15) AND TWENTY-TWO (22), IN TOWNSHIP TWO (2) NORTH, RANGE SEVEN (7) EAST OF THE WILLAMETTE MERIDIAN, IN SKAMANIA COUNTY, WASHINGTON.

SAID MAP IS DATED NOVEMBER 25, 1914, AND SHOWS ALSO THE LOCATION OF THE SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY'S LINE OF RAILROAD AND THE LOCATION OF THE PORTAGE RAILROAD OF THE CASCADES RAILROAD COMPANY WITH RELATION TO THE LOCATION OF SAID STATE ROAD NO. 8.

BY DEED DATED MAY 10, 1915, RECORDED SEPTEMBER 10, 1915, IN BOOK P AT PAGE 373 OF THE DEED RECORDS OF SKAMANIA COUNTY, WASHINGTON, THE STATE OF WASHINGTON ACQUIRED TITLE TO THE RIGHT OF WAY FOR SAID STATE ROAD NO. 8 ACROSS THE LANDS OF WARREN PACKING COMPANY SITUATED IN SECTIONS FOURTEEN (14), FIFTEEN (15) AND TWENTY-TWO (22), TOWNSHIP AND RANGE AFORESAID. THE SAID DEED CORRECTLY DESCRIBES THE RIGHT OF WAY SO ACQUIRED, WHICH LIES ENTIRELY ON THE NORTH SIDE OF THE SPOKANE, PORTLAND AND SEATTLE RAILWAY COMPANY'S RAILWAY AND ALSO ON THE NORTH SIDE OF THE SAID PORTAGE RAILWAY.

THE SAID STATE ROAD WAS CONSTRUCTED ON THE RIGHT OF WAY SO ACQUIRED FROM WARREN PACKING COMPANY AND ON THE LOCATION SHOWN ON THE SAID MAP, AND THE SAID RIGHT OF WAY HAS SINCE THE DATE OF ITS ACQUISITION BEEN USED AND OCCUPIED BY THE STATE OF WASHINGTON FOR HIGHWAY PURPOSES. THIS ROAD WAS AFTERWARD MADE A PRIMARY STATE HIGHWAY AND ITS NAME WAS CHANGED TO THE NORTH BANK HIGHWAY BY CHAPTER 110, SECTION 6 OF THE LAWS OF WASHINGTON FOR 1919. NO OTHER LANDS OF WARREN PACKING COMPANY IN SAID SECTIONS HAVE BEEN OCCUPIED BY THE STATE OF WASHINGTON UNDER SAID DEED.

THE ATTACHED COPY OF THE ORIGINAL MAP ON FILE IN MY OFFICE HAS BEEN PREPARED AND THIS AFFIDAVIT HAS BEEN EXECUTED BY ME AT THE REQUEST OF WARREN PACKING COMPANY IN ORDER THAT THERE MAY BE NO QUESTION, DOUBT OR DISPUTE IN THE FUTURE AS TO THE CORRECT LOCATION OF THE LANDS CONVEYED BY SAID WARREN PACKING COMPANY TO THE STATE OF WASHINGTON BY SAID DEED OF MAY 10, 1915, AND PARTICULARLY IN ORDER THAT THE POINT OF BEGINNING MENTIONED IN THE DESCRIPTION CONTAINED IN SAID DEED MAY BE MORE ACCURATELY LOCATED, SAID POINT OF BEGINNING BEING AT THE INTERSECTION OF THE NORTH LINE OF THE LANDS OWNED BY WARREN PACKING COMPANY AND THE SOUTH LINE OF THE RIGHT OF WAY OF SAID STATE ROAD NO. 8, SAID POINT OF INTERSECTION BEING IN LOT ONE (1) OF SECTION FOURTEEN (14), TOWNSHIP TWO (2) NORTH OF RANGE SEVEN (7) EAST OF THE WILLAMETTE MERIDIAN.
