GRANT DEED

JOHN W. COOK, A SINGLE PERSON, IN CONSIDERATION OF SEVEN HUNDRED FIFTY (\$750.00) DOLLARS TO HIM IN HAND PAID, THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, DOES HEREBY GRANT TO HERBERT EAKIN ALL THAT REAL PROPERTY SITUATE IN THE COUNTY OF SKAMANIA, STATE OF WASHINGTON, DESCRIBED AS FOLLOWS:
