WHEREAS, J. P. O'BRIEN, AS TRUSTEE, HAS RESIGNED SAID OFFICE OF TRUSTEE AND DESIRES TO RELINQUISH SAID TRUST AND TO BE RELIEVED OF THE DUTIES AND RESPONSIBILITIES THEREOF; AND

WHEREAS, SAID OREGON-WASHINGTON RAILROAD & NAVIGATION COMPANY IS WILLING THAT SAID J. P. O'BRIEN AS TRUSTEE, SHALL VACATE SAID TRUSTEESHIP, AND BE RELEASED FROM THE DUTIES AND RESPONSIBILITIES THEREOF.

SECOND: OREGON-WASHINGTON RAILROAD & NAVIGATION COMPANY, BENEEICIARY, HAS RELEASED AND DOES HEREBY RELEASE THE SAID J. P. O'BRIEN FROM THE OFFICE OF TRUSTEE OF SAID LANDS, RIGHTS OF WAY AND PROPERTY, AND DOES HEREBY FOREVER RELEASE AND DISCHARGE THE SAID J. P. O'BRIEN FROM ALL FURTHER LIABILITY IN RESPECT THERETO.

IN WITNESS WHEREOF, THE SAID J. P. O'BRIEN AS TRUSTEE, HAS HEREUNTO SET HIS HAND AND SEAL, AND OREGON-WASHINGTON RAILROAD & NAVIGATION COMPANY HAS SUB-ACRIBED ITS CORPORATE NAME AND AFFIXED ITS SEAL BY AND THROUGH ITS PROPER OFFICERS THEREUNTO DULY AUTHORIZED.
