THIS INDENTURE, MADE THIS 5TH DAY OF JULY A.D. 1921 BETWEEN HARRY HAZARD AND LOTTIE HAZARD, HIS WIFE PARTIES OF THE FIRST PART, AND WILLIAM G. WILLIAMS, A BACHELOR PARTY OF THE SECOND PART,

WITNESSETH, THAT THE SAID PARTIES OF THE FIRST PART, FOR AND IN CONSIDERATION OF THE SUM OF THIRTY-FIVE AND NO/100 DOLLARS, TO THEM IN HAND PAID BY THE SAID PARTY OF THE SECOND PART, THE RECEIPT WHEREOF IS HEREBY ACKNOWLEDGED, DO HEREBY GRANT, BARGAIN, SELL AND CONVEY, UNTO THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS FOREVER, ALL THAT TRACT OR PARCEL OF LAND, LYING AND BEING IN THE COUNTY OF SKAMANIA AND STATE OF WASHINGTON, AND DESCRIBED AS FOLLOWS, TO-WIT:

COMMENCING AT THE SOUTHWEST CORNER OF LOT 1 OF STEVENSON PARK ADDITION ACCORDING TO THE PLAT THEREOF ON FILE IN THE OFFICE OF THE AUDITOR OF SKAMANIA COUNTY, WASHINGTON, SAID CORNER BEING IN THE CENTER OF KANAKA CREEK ROAD; THENCE SOUTHEASTERLY ALONG THE CENTER OF KANAKA CREEK ROAD TO INTERSECTION WITH THE CENTER OF STRAWBERRY ROAD (ORIGINAL SURVEY AND LOCATION), THENCE NORTHEASTERLY TO INTERSECTION WITH THE SOUTH LINE OF SAID LOT 1, STEVENSON PARK ADDITION, THENCE WEST TO THE PLACE OF BEGINNING, CONTAINING ONE-FOURTH ACRE MORE OR LESS.

SUBJECT TO EASEMENTS FOR SAID ROADS.

AND THE SAID HARRY HAZARD AND LOTTIE HAZARD, HIS WIFE PARTIES OF THE FIRST PART, FOR THEMSELVES AND THEIR HEIRS, EXECUTORS AND ADMINISTRATORS, DO COVENANT WITH THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, THAT THEY ARE WELL SEIZED IN FEE OF THE LANDS AND PREMISES AFORESAID, AND HAVE GOOD RIGHT TO SELL AND CONVEY THE SAME IN MANNER AND FORM AFORESAID; THAT THE SAME ARE FREE FROM ALL INCUMBRANCES WHATSOEVER AND THE ABOVE BARGAINED AND GRANTED LANDS AND PREMISES, IN THE QUIET AND PEACEFUL POSSESSION OF THE SAID PARTY OF THE SECOND PART, HIS HEIRS AND ASSIGNS, AGAINST
