POWER OF EXECUTIVE COMMITTEE.

SECTION 3.

Wherever any action is required or may be taken hereunder by vote or otherwise of the Board of Trustees of the Corporation, such action may be taken by the Executive Committee of such board with the same force and effect as though taken by the Board of Trustees, anything contained in this indenture to the contrary notwithstanding.

SECTION 4.

The provisions of this indenture may from time to time be modified or amended by proper instrument or instruments executed for that purpose by the Corporation, and the Trustees hereunder, upon the consent of the holders of at least seventy-five percent (75%) of the aggregate principal amount of bonds issued hereunder and then outstanding.

EXECUTION IN COUNTERPARTS.

SECTION 5.

For the purpose of facilitating the record hereof, this indenture may be executed in any number of counterparts, each of which shall be and shall be taken to be an original and all collectively but one instrument.

MARGINAL NOTES AND INDEX.

SECTION 6.

Any marginal notes hereon or index or table of contents are no part of this indenture and shall not be deemed to affect the meaning or construction of any of its provisions.

SECTION 7.

For convenience of reference this indenture is effective as of July 1, 1928 but the true date of signature is July 3rd, 1928.
