PRIVILEGE IS ALSO HEREBY GRANTED TO ENTER IN AND UPON SAID PREMISES TO ERECT THE SAME, PROVIDED HOWEVER, SAID FLUME IS TO BE ERECTED IN THE MOST PRACTICABLE PLACE FOR THE USES AND PURPOSES TO WHICH SAME IS TO BE PUT AND WITH DUE REGARD TO THE CONVENIENCE OF THE GRANTORS HEREIN, AND SHALL BE OF A WIDTH OF THIRTY (30) FEET, AND THE PRIVILEGES GRANTED HEREUNDER ARE SO GRANTED TO CONTINUE AND EXIST FOR A PERIOD OF TWENTY-FIVE (25) YEARS FROM AND AFTER THE DATE OF THIS INSTRUMENT. THE LAND ACROSS WHICH SAID RIGHT OF WAY IS GRANTED BY THIS DEED IS DESCRIBED AS FOLLOWS:

NORTHWEST QUARTER (NW) OF SOUTHWEST QUARTER (SW) OF SECTION TWENTYFOUR (24), TOWNSHIP THREE (3) NORTH, RANGE NINE (9) EAST, W.M., AND THE ATTACHED
MAP SHOWS SUBSTANTIALLY THE PROPOSED POINTS OF CROSSING SAID LANDS.

IT IS AGREED BETWEEN THE PARTIES TO THIS INSTRUMENT THAT WORK ON THE CONSTRUCTION OF SAID FLUME SHALL BEGIN WITHIN THE PERIOD OF SIX (6) MONTHS FROM AND AFTER THE DATE HEREOF, AND THAT SAME SHALL BE COMPLETED AND IN OPERATION WITHIN ONE YEAR FROM THE DATE WHEN CONSTRUCTION WORK ON SAID FLUME SHALL HAVE BEGUN HEREUNDER.
