THE GRANTORS HEREIN, WILBUR H. GALLIGAN AND MARGARET L. GALLIGAN, HIS WIFE, OF HOOD RIVER, OREGON, FOR AND IN CONSIDERATION OF THE SUM OF \$500. TO THEM IN HAND PAID, THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, DO HEREBY GRANT, BARGAIN, SELL AND CONVEY UNTO THE DRANO FLUME & LUMBER COMPANY, A CORPORATION, OF THE STATE OF WASHINGTON, A RIGHT OF WAY FOR A WATER FLUME IN WHICH TO FLUME TIMBER PRODUCTS OF ALL KINDS, OVER AND ACROSS THE LANDS HEREINAFTER DESCRIBED, GIVING AND GRANTING THE PRIVILEGE HERewith OF ENTERING IN AND UPON SAID RIGHT OF WAY TO LOCATE, ERECT AND MAINTAIN THE SAID FLUME, AND TO OPERATE THE SAME; THE GRANTORS RESERVING THE RIGHT TO TRAVEL AND USE THE PRESENT ROADWAYS ACROSS SAID RIGHT OF WAY UNDER SAID FLUME AS THE SAME IS TO BE ERECTED; SAID RIGHT OF WAY TO BE THIRTY, (30) FEET IN WIDTH, AND FIFTEEN FEET ON EACH SIDE OF THE CENTER LINE OF THE SAME, AS NOW SURVEYED, STAKED OUT AND MARKED OVER AND ACROSS SAID PREMISES, AND THE RIGHT AND PRIVILEGE HEREBY GRANTED SHALL CONTINUE AND EXIST IN AND BELONG TO THE SAID DRANO FLUME & LUMBER COMPANY, AND ITS SUCCESSORS AND ASSIGNS, FOR A PERIOD OF TWENTY-FIVE YEARS FROM AND AFTER THE DATE HEREOF; PROVIDED THAT WHEN SAID GRANTEE, OR ITS SUCCESSORS AND ASSIGNS SHALL CEASE TO OPERATE SAID FLUME, THE RIGHT AND PRIVILEGE HEREBY GRANTED SHALL REVERT TO THE GRANTORS, THEIR HEIRS AND ASSIGNS. THE PREMISES OVER WHICH SAID RIGHT OF WAY IS HEREBY GRANTED IS DESCRIBED AS FOLLOWS:

LOTS ONE (1), AND TWO (2) AND THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 30, TOWNSHIP 3 NORTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN; SAID RIGHT OF WAY IS MORE DEFINITELY DESCRIBED AND LOCATED OVER AND ACROSS SAID PREMISES ON THE PLAT THEREOF HERETO ANNEXED AND MADE A PART OF THIS GRANT.
