PRACTICABLE PLACE FOR THE USES- AND PURPOSES TO WHICH SAME IS TO BE PUT AND WITH DUE REGARD TO THE CONVENIENCE OF THE GRANTORS HEREIN, AND SHALL BE OF A WIDTH OF TWENTY (20) FEET, AND THE PRIVILEGES GRANTED HEREUNDER ARE SO GRANTED TO CONTINUE AND EXIST FOR A PERIOD OF TWENTY-FIVE (25) YEARS FROM AND AFTER THE DATE OF THIS INSTRUMENT. THE LAND ACROSS WHICH SAID RIGHT OF WAY IS GRANTED BY THIS DEED, IS DESCRIBED AS FOLLOWS:

SOUTHEAST QUARTER (SET) OF NORTHEAST QUARTER (NET) OF SECTION TWENTY-SIX (26), TOWNSHOP THREE (3) NORTH, RANGE NINE (9) EAST, W.M.

IT IS AGREED BETWEEN THE PARTIES TO THIS INSTRUMENT THAT WORK ON THE CONSTRUCTION OF SAID FLUME SHALL BEGIN WITHIN THE PERIOD OF SIXTEEN (16) MONTHS FROM AND AFTER THE DATE HEREOF, AND THAT SAME SHALL BE COMPLETED AND IN OPERATION WITHIN TWO (2) YEARS FROM THE DATE WHEN CONSTRUCTION WORK ON SAID FLUME SHALL HAVE BEGUN HEREUNDER.

PURPOSES FROM OUT THE SAID FLUME, SUBJECT TO THE FIRST AND PRIOR RIGHT OF THE PORTLAND RAILWAY LIGHT & POWER COMPANY, A CORPORATION, OF THE STATE OF OREGON, TO THE USE OF THE WATER PASSING THROUGH SAID FLUME, AND SUBJECT TO SAID FIRST AND PRIOR RIGHT THESE SAID GRANTORS ARE CAVEN THE RIGHT TO USE WATER FOR IRRIGATION PURPOSES THEREFROM, CONNECTION WITH SAID FLUME TO BE MADE AT A POINT ON THE GRANTORS OWN LAND, AND SAID WATER TO BE BY THEM USED ONLY IN SUCH MANNER AND AT SUCH TIMES AS WILL NOT INTERFERE WITH THE CONDUCT OF THE FLUME FOR THE PURPOSES FOR WHICH SAME IS ERECTED.
