SAID GRANTORS DO HEREBY SELL, ASSIGN, TRANSFER AND SET OVER UNTO THE SAID DRANO FLUME & LUMBER COMPANY ALL THOSE CERTAIN RIGHTS AND PRIVILEGES HAD AND HELD BY SAID GEORGE BROUGHTON AND SAID W. D. ARNOLD IN, UNDER, OVER, UPON AND ACROSS ALL OF THOSE CERTAIN ROADS AND HIGHWAYS GRANTED TO SAID GEORGE BROUGHTON AND W. D. ARNOLD BY THAT CERTAIN ORDER OF THE BOARD OF COUNTY COMMISSIONERS OF SKAMANIA COUNTY, WASHINGTON, ON THE 7TH DAY OF JUNE, 1921, TOGETHER WITH ALL RIGHTS AND PRIVILEGES BY SAID ORDER GRANTED TO AND CONFERRED UPON SAID GEORGE BROUGHTON AND W. D. ARNOLD, SUBJECT, HOWEVER, TO ALL OF THE TERMS AND CONDITIONS IN SAID ORDER CONTAINED AND SET FORTH. THE SAID DRANO FLUME & LUMBER COMPANY BY THE ACCEPTANCE HEREOF DOES UNDERTAKE AND AGREE TO ASSUME AND PERFORM ALL OF THE TERMS AND CONDITIONS ENUMERATED AND SET FORTH IN SAID ORDER TO BE KEPT AND PERFORMED BY THE SAID GEORGE BROUGHTON AND W. D. ARNOLD, AND DOES AGREE TO SAVE HARMLESS THE SAID GEORGE BROUGHTON AND W. D. ARNOLD AND SAID COUNTY OF SKAMANIA, AND EACH OF THEM, FROM ANY AND ALL DAMAGES WHICH MAY ARISE FROM THE CONSTRUCTION OR MAINTENANCE OF THE FLUME CROSSINGS REFERRED TO IN SAID ORDER. AND THE SAID DRANO FLUME & LUMBER COMPANY DOES FURTHER UNDERTAKE AND AGREE TO ASSUME AND PERFORM EACH AND EVERY CONDITION, TERM, OBLIGATION, DUTY AND LIABILITY WHICH BY THE TERMS OF SAID ORDER ARE THEREBY IMPOSED UPON THE SAID GEORGE BROUGHTON AND W. D. ARNOLD, OR EITHER OF THEM, AND DOES AGREE TO RELEASE SAID GEORGE BROUGHTON AND W. D. ARNOLD FROM ANY AND ALL OBLIGATIONS, DUTY OR LIABILITY OF WHATSOEVER KIND, NATURE OR DESCRIPTION ARISING OUT OF SAID FRANCHISE OR THE PERFORMANCE OR FAILURE TO PERFORM ANY AND ALL OF THE TERMS AND CONDITIONS THEREOF.
