THE CASE MAY BE, BY THEM AS TRUSTEES AND NOT AS INDIVIDUALS, AND EVERY PERSON OR CORPORATION CONTRACTING WITH THE TRUSTEES SHALL LOOK ONLY TO THE FUNDS AND RECEIPTS OF SAID TRUST FOR PAYMENT UNDER SUCH CONTRACT OR CONTRACTS OR FOR THE PAYMENT OF ANY DEBT, MORTGAGE, JUDGMENT OR DECREE, OR PAYMENT OFTANY MONEY THAT MAY OTHERWISE BECOME DUE OR PAYABLE ON THE ACCOUNT OF THE ACTS OF THE TRUSTEES PURSUANT TO SAID TRUSTS, AND FOR ANY OTHER OBLIGATION ARISING UNDER THES AGREE, MENT IN WHOLE OR IN PART; AND NEITHER THE TRUSTEES NOR THE SHARE-HOLDERS, PRESENT OR FUTURE, SHALL BE PERSONALLY LIABLE THEREFOR.

- 13. TERMINATION OF TRUST THAT SAID TRUST SHALL RUN FROM THE EXECUTION OF THIS INSTRUMENT UNTIL THE FIRST MONDAY IN JULY 1922, AND FROM YEAR TO
 YEAR THEREAFTER, AND CONTINUE FOR A PERIOD NOT LONGER THAN TWENTY-FIVE (25)
 YEARS FROM THE DATE OF THE EXECUTION OF THIS INSTRUMENT; AND THE TERMINATION
 THEREOF, OR ITS DISSOLUTION AT ANY TIME, SHALL IN NO WAY AFFECT THE INTERESTS OF
 CO-TENANTS OR SHARE-HOLDERS IN SAID PROPERTY, OR DISSOLVE OR CHANGE THE RELATIONSHIP OF CO-TENANTY IN COMMON AMONG THEM.
- 14. AMENDMENTS THAT THIS DECLARATION OF TRUST MAY BE AMENDED BY THE AFFIRMATIVE VOTE IN WRITING OF TWO-THIRDS (2/3) OF THE INTERESTS OR SHARES HELD BY SUCH CO-TENANTS AND SHARE-HOLDERS, BUT NO AMENDMENT SHALL BE MADE WHICH WILL OPERATE IN ANY WAY TO GIVE TO THE CO-TENANT OR SHARE-HOLDERS ANY CONTROL OVER THE FUNDS OR RECEIPTS OF THE TRUST OR ANY VOOCE IN THE MANAGEMENT OF THE BUSINESS OF THE TRUST, UNLESS SUCH AMENDMENT TO THAT EFFECT IS SIGNED BY ALL THE CO-TENANTS AND SHARE-HOLDERS.
- 15. EXPENSES OF ORGANIZATION THAT THE TRUSTEES SHALL HAVE AUTHORITY.

 TO PAY OUT OF THE FUNDS OF THE TRUST ALL THE EXPENSES FOR THE CREATION OF SAID

 CO-TENANCY, AGENCY AND TRUST.
