THE GRANTOR, PETER PETERSON, A SINGLE MAN, FOR AND IN CONSIDERATION OF THE SUM OF ONE DOLLAR TO HIM IN HAND PAID BY HARRIET A. TURNER, A WIDOW, THE GRANTEE, DOES HEREBY BARGAIN, SELL AND CONVEY UNTO THE SAID GRANTEE, THE FOLLOWING DESCRIBED PROPERTY IN SKAMANIA COUNTY, STATE OF WASHINGTON, TO-WIT:

ALL THAT PORTION OF LOT TEN (10) SECTION TWENTY-FOUR (24) TOWNSHIP THREE (3) NORTH, RANGE SEVEN AND ONE-HALF (7½) EAST OF THE WILLAMETTE MERIDIAN, LYING SOUTH OF WOLF CREEK.

TO HAVE AND TO HOLD THE SAME UNTO THE GRANTEE HER HEIRS AND ASSIGNS FOREVER.

THIS DEED IS MADE FOR THE PURPOSE OF RECONVEYING TO THE SAID GRANTEE THE PORTION OF LOT TEN ABOVE DESCRIBED WHICH WAS CONVEYED TO GRANTOR HEREIN BY ERROR IN THAT CERTAIN DEED DATED JULY 7TH 1913 MADE BY HARRIET A. TURNER TO PETER PETERSON, AND RECORDED ON THE 7TH DAY OF JULY 1913 IN BOOK 0 OF DEEDS AT PAGE 355 RECORDS OF SKAMANIA COUNTY, WASHINGTON. AND THE SAID GRANTOR DOES HEREBY COVENANT AND AGREE TO AND WITH THE SAID GRANTEE, HER HEIRS AND ASSIGNS, THAT HE HAS INCURRED NO INCUMBRANCE UPON THE SAID LAND, AND THAT HE WILL, AND HIS HEIRS, ADMINISTRATORS AND EXECUTORS SHALL, FOREVER WARRANT AND DEFEND THE TITLE THERETO AS AGAINST ANY CLAIM ACCRUING THROUGH HIM.
