KNOW ALL MEN BY THESE PRESENTS, DATED THIS 29TH DAY OF JULY, 1921, THAT ALICE C. BRISTOL, FORMERLY THE WIFE OF LELAND E. BRISTOL, DECEASED, SHE BEING NOW A SINGLE WOMAN, IN CONSIDERATION OF THE SUM OF ONE DOLLAR PAID BY LOUIS T. MERWIN, DOES REMISE, RELEASE AND FOREVER QUITCLAIM UNTO SAID LOUIS T. MERWIN, AND UNTO HIS HEIRS AND ASSIGNS FOREVER, ALL HER RIGHT, TITLE AND INTEREST IN AND TO THAT CERTAIN REAL PROPERTY, SITUATED IN THE STATE OF WASHINGTON, IN SKAMANIA AND KLICKITAT COUNTIES, OR IN EITHER OF SAID COUNTIES, TO-WIT:
