

ABOUT SAID MINE.

(F) TO DO AND PERFORM SUCH WORK EITHER BY A SUPERINTENDENT EMPLOYED BY THEM OR BY LETTING CONTRACTS IN THEIR DISCRETION.

(G) TO PURCHASE AND INSTALL CHEMICAL AND METALLURGICAL WORKS AND REFINERIES FOR THE PRODUCTION OF MOLYBDIC ACID, METALIC MOLYBDENUM, AND FERRO-MOLYBDENUM ALLOYS, ALSO THE MANUFACTURING OF ELECTRICAL RESISTANCE WIRES AND ACCESSORIES IN THE ELECTRIC FIELD; AND ALSO THE NECESSARY PROVISIONS FOR THE MARKETING OF THE SAID PRODUCTS.

(H) TO PURCHASE AND INSTALL AN ANALYTICAL LABORATORY FOR ESTABLISHING CONTROL ANALYSIS OF THE MINE PRODUCT; I.E. TO DETERMINE THE METALLIC TENOR OF MOLYBDENUM IN THE ORE; ALSO, A RESEARCH LABORATORIAL INSTALLATION FOR THE PURPOSE OF DOING ANY AND ALL KINDS OF RESEARCH AND ALLIED MINERALS, METALLURGICAL AND CHEMICAL DETERMINATIONS AND MAKING QUALITATIVE AND QUANTITATIVE ANALYSES ON THE SAID FURNACE PRODUCTS OF THE CHEMICAL AND METALLURGICAL WORKS AND REFINERIES.

(I) TO ESTABLISH THE PRINCIPAL OFFICE OF THE TRUST AT CASTLE ROCK, WASHINGTON, AND SUB-OFFICE AT ANY OTHER PLACES WHERE THEY SHALL DEEM IT EXPEDIENT; TO PURCHASE EQUIPMENT FOR SUCH OFFICES AND TO EMPLOY OFFICE HELP, INCLUDING A SECRETARY AND LEGAL COUNSEL, AND TO FIX THE COMPENSATION TO BE PAID THEM.

(J) AND TO DO AND PERFORM EACH AND EVERY ACT THAT SHALL BE NECESSARY OR EXPEDIENT IN THE ADMINISTRATION OF SAID TRUST.
