Stevenson Co, to P.S.C.Wills

REAL AND CHATTEL MORTGAGE

Whereas, pursuant to a resolution of the trustees of the Stevenson Water Company, the said Water company did, on the 12th day of January, 1929, enter into a written agreement wherein the said Wills agreed to furnish to the Water Company additional water and that the said corporation agreed to pay, therefor, the sum of Fifty (\$50.00) Dollars per month for a period of twenty-five years from the date of said contract.

and Whereas, said corporation was duly authorized to execute such instruments as may be necessary to secure said Wills the faithful performance of said contract.

NOW, THEREFORE, the said Stevenson Water Company, a corporation, does hereby mortgage unto P.S.C.Wills all of its property of every kind, name and nature, real and personal, including pipelines, franchises, Accounts receivable, choses in action, water and water rights and any and all other personal property by it owned or hereafter acquired, either in addition to, or in replacement of its present property or in any manner whatever, together with all easements, rights of way and real property, including the Learned Springs, sometimes called Cedar Springs, and also the John Skaar Spring and the land thereto belonging and the Reservoir with the land thereto belonging and with all pipe lines running into the same and out of said Springs and Reservoir, it being the intention of this mortgage to mortgage all of the real and personal property of the said Stevenson Water Company situated in Skamania County, Washington.
