M.J.Keenan et ux to H.W.peterson

KNOW ALL MEN BY THESE PRESENTS,That M.J.Keenan and Amy Keenan husband and wife the parties of the first part,for and in the consideration of the sum of Ten and no/100 (\$10.00) dollars of the United States of America,to them in hand paid by H.W.Peterson the party of the second part,the receipt of which is hereby acknowledged,have granted bargained sold,assigned,transferred and set over,and by these presents do grant,bargain,sell, assign,transfer and set over unto the said party of the second part,a certain INDENTURE OF MORTGAGE,bearing date the 17th day of October A.D.One thousand Nine Hundred and Twenty Eight made and executed by Frank N.Hill and Ina E.Hill,husband and wife,to the said parties of the first part,to secure the payment of the sum of Fourteen Hundred Eighty and no/100 (\$1480.00) Dollars together with the note or obligation therein described and the money due,or to grow due thereon,with the interest;which said indenture of mortgage was recorded in the office of the recorder of conveyances of the county of Skamania,State of Washington in book S. of mortgages page 334 on the 29th day of October A.D.1928.

TO HAVE AND TO HOLD,The same unto the said party of the second part his executors administrators and assigns,for his use and benefit,subject only to the provisions in the said INDENTURE OF MORTGAGE MENTIONED.

And the said parties of the first part do hereby covenant to and with the said party of the second part,that the said parties of the first part are the lawful owners and holders of the said note and mortgage,and that they have good right to sell,transfer and assign the same as aforesaid,and that there is now due and owing upon the said note and mortgage the sum of Fourteen Hundred Eighty and no/100 (\$1480.00) dollars,with interest from the 17th day of January A.D.One Thousand Nine Hundred and Twenty Nine
