15754 Partial Release of Mortgage

Spencer Biddle to Beacon Lake Corporation.

KNOW ALL MEN BY THESE PRESENTS, That I, Spencer Biddle, having received the sum of Dollars as a partial payment on that certain mortgage executed by Beacon Lake Corporation, a Washington corporation, mortgagor dated October 23, 1928 in favor of Spencer Biddle, mortgagee and recorded in book S record of mortgages for the County of Skamania, State of Washington on page 332 on the 26th day of October, 1928 which said mortgage was recorded in book S of Mortgages, page 337, on the 3rd day of November, 1928, do hereby release from the lien of said mortgage the following described premises therein described, to-wit:

Beginning at a point on the section line between Sections 26 and 35, township 2 North Range 6 East of the Willamette Meridian, and from which point the northeast corner of said Section 35 bears east 460.0 feet; thence South 65°31' West a distance of 800.00 feet; thence North 66°44' West a distance of 130 feet, more or less, to a point on the west line of the northeast quarter of the northeast quarter of said Section 35; thence north along said west line of the northeast quarter of the northeast quarter of said section, a distance of 20.0 feet; thence North 72° 56' east a distance of 886.6 feet, more or less, to the place of beginning. The area of the parcel of land hereby released is 1.1 acres, more or less. that and the remainder of said lands in said mortgage specified shall remain subject thereto as heretofore.
