THIS INDENTURE, Made and entered into this 15th day of June 1929 by and between Coy Catlin Post No. 137, Department of Washington, The American Legion, a corporation, party of the first part, hereinafter designated as mortgagor, and Wm. R. Price, Trustee, party of the second part, hereinafter designated Trustee, WITNESSETH:

WHEREAS, The Board of Trustees of the mortgagor company by resolution regularly adopted and for the purpose of securing funds for the construction of a Legion hall, did determine to borrow upon his negotiable coupon bonds the sum of \$4000.00; said bonds to be serial in form, payable from one to five years as therein provided, with interest thereon at the rate of six per cent per annum as therein specified, said bonds to be dated June 15, 1929, and to be known as "Six Per Cent First Mortgage Serial Bond"; and,

WHEREAS, The Board of Trustees aforesaid did at its said meeting, order and direct that the form of said bonds and of the coupons to be attached thereto, shall be substantially as follows, to-wit:
