FISHER FOR THE SUM OF NINE THOUSAND TWO HUNDRED TEN AND 97/100 (9,210.97) DOLLARS, SHE BEING THE HIGHEST BIDDER, AND THAT BEING THE HIGHEST SUM BIDDEN THEREFOR,
