F. M. FOWLER TO J. E. ROGERS

THIS INDENTURE made and entered into this 24th day of March, 1930 by and between F. M. Fowler, party of the first part and J. E. Rogers, party of the second part, Witnesseth:

That Whereas, the party of the first part is indebted to the party of the second part in the sum of \$4,000. and

Whereas, the party of the first part owns an equity under a contract of purchase made and entered into the 3rd day of March, 1930, by and between J. E. Duffy, venor, and F. M. Fowler, vendee, covering the real property known as the Felton property being more particularly described as follows, to-wit:

SW $\frac{1}{4}$  of NE $\frac{1}{4}$  E $\frac{1}{2}$  of NW $\frac{1}{4}$  NW $\frac{1}{4}$  of NW $\frac{1}{4}$ , SE $\frac{1}{4}$  of NE $\frac{1}{4}$  and N $\frac{1}{2}$  of SE $\frac{1}{4}$  of Section 9, and NW $\frac{1}{4}$  of SW $\frac{1}{4}$ , Section 10 Township 3 North, Range 9 East of Willamette Meridian, Skamania County, Washington,

which said contract provides for payment as the timber is cut from said property in a sum not less than \$833.00 each two months and at the rate of One Dollar per thousand feet, and upon which the party of the first part has paid the sum of \$500.00, and

Whereas, the party of the first part is also the owner of certain logs, piling and other timber products lying and being on the property known as the Fouts property described as SE $\frac{1}{4}$  of NW $\frac{1}{4}$ , E $\frac{1}{2}$  of SW $\frac{1}{4}$  S $\frac{1}{2}$  of SE $\frac{1}{4}$  Section 23 Township 3 North, Range 9 East of Willamette Meridian, Skamania County, Washington, upon which said logs, timber and other timber products the party of the first part is indebted for stumpage at the rate of \$2.50 per thousand feet, The said logs and piling consisting of approximately 375 thousand feet of saw logs and 125 pieces of piling lying and being upon the above described property, and approximately
