BANK OF STEVENSON TO STEVENSON WATER CO.  
Release of Mortgage.

KNOW ALL MEN BY THESE PRESENTS, That Bank of Stevenson, a banking corporation duly organized and existing under and by virtue of the laws of the State of Washington, does hereby certify and declare that,

WHEREAS, the Stevenson Water Company, a corporation, did on the 28th day of March, 1916 by its certain indenture convey to the said Bank of Stevenson, as trustee, certain real and personal property in Skamania County, Washington, more particularly described in said mortgage, reference to which is hereby made, and

WHEREAS, said conveyance was given in trust to secure the payment of certain bonds in the aggregate sum of \$10,000. numbered A-1 to A-20, which said bonds are fully described in said indenture, and

WHEREAS, said Bank of Stevenson has held all the bonds issued under and virute of said trust deed of which there is still outstanding in the hands of said Bank of Stevenson bonds of said issue in the aggregate sum of \$4000.00 principal, and \$80.00 interest thereon, and

WHEREAS, the said Bank of Stevenson is authorized under the terms of said trust deed to release, cancel and satisfy the same upon payment of the full amount to and unpaid thereunder, and

WHEREAS, there has this day been deposited with the said trustee the sum of \$4080.00, in full payment of all of said bonds and interest now outstanding and unpaid. In Consideration of such payment the above mentioned trust deed, dated the 28th day of March, 1916, made and executed by the Stevenson Water Company, a corporation, as party of the first part therein, to Bank of Stevenson, party of the second part, there in, and recorded on the 29th day of March, 1916, at page 486, "P" of Deeds, records of Skamania County, Washington, is together with the bonds and coupons thereunto attached and all indebtedness thereby secured. fully paid and is hereby satisfied, released and discharged.
