THIS AGREEMENT, MADE THE 11TH DAY OF JULY 1921 BETWEEN CAROLINE SHOLIN AND O. SHOLIN, HER HUSBAND OF THE FIRST PART, AND T. E. HOOKER AND MYRTLE M. HOOKER, HIS WIFE OF THE COUNTY OF SKAMANIA AND STATE OF WASH., OF THE SECOND PART.

WITNESSETH, THAT IN CONSIDERATION OF THE STIPULATIONS HEREIN CONTAINED, AND THE PAYMENTS TO BE MADE AS HEREINAFTER SPECIFIED, THE FIRST PARTIES HEREBY AGREE TO SELL, AND THE SECOND PARTIES AGREE TO PURCHASE THE FOLLOWING DESCRIBED REAL ESTATE, SITUATE IN THE COUNTY OF SKAMANIA STATE OF WASHINGTON, TO-WIT:

LOTS EIGHT (8), AND NINE (9) OF BLOCK SIX (6) OF THE TOWN OF STEVENSON, WASH., ACCORDING TO THE OFFICIAL AND DULY RECORDED PLAT THEREOF FOR THE SUM OF SIX HUNDRED DOLLARS, ON ACCOUNT OF WHICH FIFTY AND NO/100 DOLLARS IS PAID ON THE EXECUTION HEREOF (THE RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED), AND THE REMAINDER TO BE PAID AT STEVENSON, WASH. TO BE WITH 6% INTEREST WHEN PAID AT THE DATED AND IN AMOUNTS AS FOLLOWS:

TEN DOLLARS ON OR BEFORE THE 16TH OF SEPTEMBER 1921 AND \$10.00 ON OR BEFORE THE 16TH OF EACH MONTH THEREAFTER UNTIL THE PRINCIPAL AND INTEREST ARE FULLY PAID WITH INTEREST PAYABLE MONTHLY ON DEFERRED PAYMENTS.
