THIS INDENTURE, MADE THIS 15TH DAY OF FEBRUARY 1922, BY AND BETWEEN THEO LINDIS AND EMMA J. LINDIS, HIS WIFE, PARTIES OF THE FIRST PART AND F. M. KETTENRING AND GEORGE L. DUBOIS, PARTIES OF THE SECOND PART, WITNESSETH;

H. PUTNAM, AS RECEIVER OF THE UNITED STATES DISTRICT COURT FOR THE WESTERN DISTRICT OF WASHINGTON, SOUTHERN DIVISION, OF J. K. LUMBER COMPANY, A WASHINGTON CORPORATION, ACTING PURSUANT TO THE ORDER OF COURT, AS PARTY OF THE FIRST PART THEREIN AND THEO LINDIS, PARTY OF THE SECOND PART THEREIN, FOR THE SALE BY THE SAID PARTY OF THE FIRST PART THEREIN, AND THE PURCHASE BY THE SAID PARTY OF THE SECOND PART, THEREIN, OF THE MERCHANTABLE TIMBER ON THE FOLLOWING DESCRIBED LAND, TO-WIT:
