THIS CERTIFIES that THE FEDERAL LAND BANK OF SPOKANE a corporation organized and existing under the Federal Farm Loan Act, approved July 17, 1916, for and in consideration of the sum of ONE DOLLAR and other good and valuable consideration, hereby releases from the lien of that certain mortgage executed by John F. Sweeney, et ux, to THE FEDERAL LAND BANK OF SPOKANE, Dated November 1, 1917, and recorded in Book 60 of Mortgages on page 45, in the office of the Auditor of Skamania County, State of Washington, that part of the property covered by said mortgage, described as follows:

A tract of land in Lot 6, section 31, Township 3 North, Range 8 East of Willamette & M Meridian, being more particularly described as follows: All that portion of said lot 6 that lies southeasterly of the southeasterly right of way line of said State road No. 8, and Northeasterly of a line drawn at right angles to the center line of said road at highway engineers station 183+50, containing 0.20 acres, more or less, specific details concerning all of which are to be found with that certain map of definite location now of record and on file in the office of the director of highways at Olympia, and bearing date of approval May 18, 1925, and revised March 26, 1929.

It is expressly understood that this release shall not in any way affect or impair the right of the Federal LAND BANK OF SPOKANE to hold under the said mortgage and as security for the sum remaining due thereon the remainder of the premises therein conveyed and not herein released.
