MORTGAGE

THE MORTGAGORS, Herbert A. Miller and Bessie J. Miller, his wife of Skamania County, Washington hereby mortgages to the VANCOUVER SAVINGS AND LOAN ASSOCIATION, a corporation organized under the laws of the State of Washington and having its chief place of business in the City of Vancouver, hereinafter called the mortgagee, the following described ^{real} property to-wit:

Beginning at the southwest corner of Lot McMelan Acres, according to the plat thereof recorded at page 84 Plat Book A, records of Skamania County, Washington; thence south 63° 38' west 40 feet, thence north 26° 22' West 100 feet to point of beginning of tract hereby conveyed; Thence north 26° 22' west 100 feet, thence south 63° 38' west 47½ feet, thence south 26° 22' east 100 feet, thence north 63° 38' east 47½ feet to place of beginning.

Situate in the County of Skamania, State of Washington and all interest or estate therein that the mortgagors may hereafter acquire, to secure the payments of the sum of Fifteen Hundred and no/100 dollars (\$1500.00) dollars and the interest thereon at the rate of Eight per cent per annum computed as specified in promissory note hereinafter mentioned, in equal monthly instalments of Twenty-Two and 50/100 (\$22.50) dollars, beginning on the first day of November 1930 and payable on the first day of each month thereafter.
