Gallup and Nellie Gallup his wife, the following ^{described} real estate, situate in the county of Skamania State of Washington, to-wit: Lot nineteen (19) and II of lot Eighteen (18) except the west 10 feet off of Lot eighteen (18) in Washougal home tracts, situated in sec. 31, tp N, R. 5 East of W.M., according to the official plat thereof on file in the office of the County Auditor of Skamania County, Washington, to secure the payment of the sum of Three Hundred and no/100 (\$300.00) dollars, and the interest thereon, in accordance with the tenor of a certain promissory note of which the following is a copy thereof, to-wit:

On or before one year after date, without grace, for value received, jointly and severally promise to pay Geo. H. Gallup and Nellie Gallup his wife, Three Hundred and no/100 Dollars, With interest from date until paid, at the rate of 6% per cent per annum, interest payable monthly and if not so paid, the whole sum of both principal and interest to become immediately due and collectable at the option of the holder of this note. If not so collected the interest to be added to and become part of the principal, and the same to bear interest thereafter until paid at the rate of 8 per cent per annum. Principal and interest payable in lawful money of the United States. And in case action is commenced to enforce payment of this note or any ^{portion} thereof we jointly and severally, promise to pay such additional sum as the court may adjudge reasonable as attorneys fees, It is especially agreed and consented to that a deficiency judgement may be taken in a suit upon this note
