THIS DEED OF RELEASE made this 24th day of September, 1930 by CITY BANK FARMERS TRUST COMPANY (herein called the Trustee "), a trust company duly organized and existing under the banking laws of the State of New York, to PACIFIC NORTHWEST PUBLIC SERVICE COMPANY (hereina called the "COMPANY") a corporation organized and existing under the laws of the State of Oregon, WITNESSETH that

WHEREAS, heretofore the Company under its former name, Portland Railway, Light and Power Company, executed and delivered to The National City Bank of New York, a corporation organized and existing under the national banking laws of the United States of America, as Trustee, a certain Indenture of Mortgage of Deed of Trust dated April 30,1921 (hereinafter sometimes referred to as the "Original Indenture") to secure the issue of its First Lien and Refunding Mortgage Gold Bonds, issuable in series from time to time, of which the innitial series was designated series A; said indenture Weing filed and recorded as follows;

WHEREAS, Thereafter the Copany under its then name, Portland Railway, Light and Power Company, executed and delivered to said The National City Bank of New York, as trustee, a certain Supplemental indenture dated December 18,1922, in order further to secure the payment of the principal and interest of all of its Kirst Lien and refunding Mortgage Gold Bond, said indenture being recorded as follows:
