does hereby cancel and discharge the lien of said mortgage dated february 1,1912 and said
supplemental mortgage and each and every of them and does hereby acknowledge full satisfaction thereof, and does hereby remise, convey, release and quit claim unto the said Ru
Pacific Northwest Public Service Company, its successors and assigns forever all its right,
title and interest, as Trustee, in and to the properties and frachises pledged and conveyed
by and heretofore subject to the lien of said mortgage and each and every of said supplmental mortgages and not heretofore released by the Trustee.

TO HAVE AND TO HOLD the same unto Pacific Northwest Public service company, its successors and assigns, free and clear of any liens, claims or interest whatsoever of Fidelity-Philadelphia Trust Company as Trustee, as aforesaid and the undersigned Fudelity-Philadelphia Trust. Company as Trustee hereby consents to the said mortgage dated Februaryl, 1912 and each and every of the aforesaid supplemental mortgages being discharged of record, and the Auditor of the City of Portland, Oregon, the Clerk of Multnoman county, Oregon, the county recorder of Clackamas county, oregon, the county recorder of Marion county, Oregon, the county Clerk of Columbia County, Oregon, the recorder of Washington County, Oregon, the County recorder of Clarke County Washington, and the County Auditor of Skamania Gounty, Washington, and all other public officers, if any, in whose offices the same ar any thereof may have been recorded are hereby authorized and directed to discharge the aforesaid mortgage and each and every of the aforesaid supplemental mortgages upon the records the thereof in their respective offices in accordance with the statuteshin such cases made and provided.
